PRIVACY POLICY

Our development strategy is for Decentralized applications. So we make your privacy a top priority in our privacy policies.

We will hereby inform you of our policies regarding the collection, use and disclosure of personal data when you use our Services and the choices you have associated with that data.

We use your data to provide and improve the Services. By using the Services, you agree to the collection and use of information in accordance with this policy. Otherwise defined in this Private Policy, the terms used in this Privacy Policy have the same meanings as in our Terms and Conditions.

I. COLLECTION AND USE OF INFORMATION

Cowboy Snake collects information as described below. Cowboy Snake's main goals of collecting and using information are to create your accounts, provide the Services to you, improve our Services, contact you, conduct research, and generate reports for internal use.

If you do not use (login) the service for a year, all your personal data will be deleted.

Types of data collected:

1. Personal Data

While using our Services, we may ask you to provide us with certain personally identifiable information that may be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but not limited to: Cookie Email Address and Usage Data

2. Usage data

We may also collect information that your browser sends whenever you visit our Services or when you access to the Services or through a mobile device ("Usage Data").

This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), type of browser, browser version, the pages of our Services that you access, the date and time you access, the time spent on those pages, unique device identifiers, and other diagnostic data.

When you access the Service with or through a mobile device, this Usage Data may include information such as the type of mobile device you use, your mobile unique ID, IP address of your mobile device, your mobile operating system, the type of mobile Internet browser you use, unique device identifiers, and other diagnostic data.

While you are browsing the Cowboy Snake Websites, your computer's operating system, Internet Protocol (IP) address, access time, browser type and language, and reference website address may be automatic recorded.

We may use this information to track, develop, and analyze your use of the Service. In addition, we may ask you to provide the information and we may process your personal data, including but not limited to your name, profile picture, gender, age or date of birth, link to your profile on social networking sites and other third-party websites, username and e-mail address.

We may use this information to create user profiles and provide services to you.

We may use your email address to contact you about your experience with Cowboy Snake Sites and to keep you informed of company news and promotions. Your gender and date of birth can be used to analyze user trends and target certain promotions. Your email address may be used if we have merchandise or other promotional materials that we would like to send to you.

3. Cookie data tracking

We use cookies and similar tracking technologies to track the activities on our Services and keep certain information.

Cookies are files with small amounts of data that may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies are also used such as beacons, tags, and scripts to collect and track information as well as to improve and analyze our Services.

You can instruct your browser to refuse all cookies or to indicate when a cookie is sent. However, if you do not accept cookies, you may not be able to use some parts of our Services.

*Examples of our Cookies:

Session cookies: We use Session Cookies to operate our Services.

Preference cookies: We use Preference Cookies to remember your preferences and various settings.

Security cookies: We use Security Cookies for security purposes.

II. DATA USAGE

Cowboy Snake uses the collected data for different purposes:

- Maintain and provide the service

- to keep you informed about changes to our services
- to allow you to participate in the interactive features of our Services when you choose to do so
- to give customer service and support
- Provide valuable information or analysis so that we can improve the Service
- to keep track of how the Service is being used
- to detect, prevent, and solve technical problems

III. DATA TRANSFER

Your information, including Personal Data, may be transferred to and maintained on a computer located outside of your state, province, country or other governmental jurisdiction where the law protects data may differ from the law in your jurisdiction.

If you are located outside of the United States and choose to provide information to us, please note that we transfer data, including Personal Data, to the United States and process there. In addition, we may store information on servers and devices in other countries where necessary to further protect user data.

Your agreement to this Privacy Policy, then your submission of such information constitutes your agreement to the transfer.

Cowboy Snake will take all necessary steps reasonably to ensure that your data is handled securely and in accordance with this Privacy Policy and that there will be no transfer of your Personal Data to an organization or country unless appropriate controls including the security of your data and other personal information.

IV. DATA DISCLOSURE

V. SECURITY OF DATA

Our services may contain third-party tracking tools from our service providers. Such third parties may use cookies, APIs, and SDKs in our services to enable them to collect and analyze user information on our behalf. Third parties may have access to information such as your device identifier, MAC address, IMEI, language (specific location where a certain language is used), location information geographies and IP addresses for the purpose of providing their services under their respective private rights. Our privacy policy does not cover the use of tracking tools from third parties. We have no access to or control over these third parties.

VII. LINK TO OTHER WEBSITES

Our Services may contain links to other websites not operated by us. If you click on a third-party link, you will be directed to that third-party website. We do not control and are not responsible for the content, privacy policies or practices of any third-party websites or services.
